This incentive, called the Credit for Solar Energy Devices, provides a 25% credit on the total cost of a residential solar energy system, up to \$1,000. This one-time credit applies to both primary and secondary residences within

There are no statewide Arizona solar rebates, but it does have the AZ solar tax credit. Arizona's tax credit is equal to 25% of system costs up to \$1,000, and it reduces your state income tax liability. Once the federal and state solar tax credits are applied, the price drops to about \$13,700 to install a solar photovoltaic system in Arizona.

Are solar panels tax deductible in Arizona?

In addition to the great rebates and incentives above, Arizona also offers tax exemptions for solar panel systems. The solar sales tax exemption ensures that you won't have to pay a sales tax on your system, while the solar property tax exemption means you don't need to pay a higher property tax for adding solar panels to your house.

When is the solar tax credit applied in Arizona?

Solar energy systems in Arizona get a tax credit equivalent to 25% of their value or \$1,000, whichever is less. One time: Credit is applied when you file



your taxes during the year your system is installed. Solar panels are exempt from Arizona's 5.6% sales tax, which means immediate savings when buying equipment.
