For example, let's say you install solar panels on your home in 2025, and the total cost of this installation is \$35,000. Because the solar tax credit rate for 2025 is 30%, you would be able to claim a \$10,500 tax credit. ($\$35,000 \times 30\% = \$10,500$).

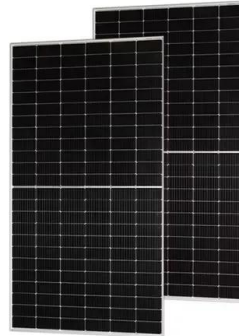
