Overview

What is EPA's \$7 billion solar for all program?

Earlier today, the Environmental Protection Agency (EPA) announced 60 awardees for its \$7 billion Solar for All program, which will create and expand solar programs that deliver meaningful benefits to underserved and disinvested communities throughout the country.

What is the Solar for all grant competition?

On April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.

Will EPA grants go to residential solar projects?

The EPA grants will go toward residential solar projects. The Environmental Protection Agency has announced the selection of 60 recipients of \$7 billion in grant awards through the Solar for All grant competition, the agency said Monday.

What is the \$7 billion solar for all program?

Under the \$7 billion Solar for All program, the 60 grant recipients will create new or expand existing low-income solar programs, which will enable over 900,000 households in low-income and disadvantaged communities to benefit from distributed solar energy.

What is a solar for all award?

One hundred percent of the Solar for All awards are meant to benefit communities defined by EPA as low-income and disadvantaged (LIDAC).

How many solar for all awards are there?



The 60 Solar for All awards include 49 state-level awards, 6 awards serving Tribes, and 5 multi-state awards, all of which will either expand existing low-income solar programs, or create new solar programs that benefit LIDAC.




