Will EPA end solar for all?

EPA Administrator Lee Zeldin announced in a post on the social platform X on Thursday that he intends to end the program, known as Solar for All, "for good, saving US taxpayers ANOTHER \$7 BILLION!" He said in a video accompanying his post that "very little money has actually been spent."
