What the federal solar credit includes: Keep in mind the federal tax credit only applies to purchased solar systems for first or second homes. Leased solar panels are excluded from the federal tax credit. The 30% credit expires in 2032, after which the credit reduces to 25% in 2033 and 22% in 2034.
