Filing this document requires paying a court-specific fee. After filing the complaint, you must notify the solar company you are suing them through a step called service of process. This must follow strict legal rules and usually involves a third party delivering a copy of the complaint and a summons to the company's registered agent.

What happens if I have a complaint about my solar Bill?

If your complaint is regarding your billing with a solar company and a regulated utility, the Division will request your bills and review them for accuracy. If a discrepancy is found, the Division will identify the error so that you will be able to represent the problem to the solar installation company or utility.

Why did Tom file a complaint against the solar company?

Feeling deceived, Tom filed a complaint against the solar company, arguing that their representative had misled him into believing all costs would qualify, and considered pursuing legal action to cover the unexpected financial liability.

Why did a customer complain about a solar agreement?

Confused by the separate roles of the solar and finance companies, the customer filed complaints and left negative reviews, frustrated by the lack of
