**UNDERSTAND YOUR GRIEVANCES:** Before initiating a complaint, it's crucial to clearly identify and categorize the specific issues affecting your solar energy



system. 2. GATHER EVIDENCE: Collect all relevant documentation, including contracts, warranties, and any records of communication with service.

Your first step should be to get organized and collect all the paperwork you've received from the installer including your proposal, contract, correspondence (including texts), and related paperwork from the local jurisdiction and utility. Document everything! It's also helpful to make a timeline. How do I file a complaint against a solar company?

Filing this document requires paying a court-specific fee. After filing the complaint, you must notify the solar company you are suing them through a step called service of process. This must follow strict legal rules and usually involves a third party delivering a copy of the complaint and a summons to the company's registered agent.

Why do customers file lawsuits against solar companies?

One of the most significant reasons customers file complaints or lawsuits against solar companies is misleading sales tactics and overpromises made during the sales process.

Why did a customer complain about a solar agreement?

Contractors State License Board (CSLB)'s new Solar Complaint Form is now available. The form should be used by consumers when reporting problems related to solar installation. Between July 2019 and June 2020, CSLB received 1,067 solar complaints.

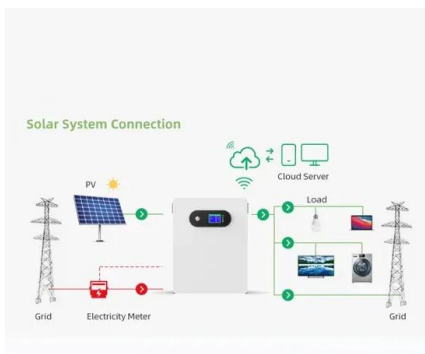

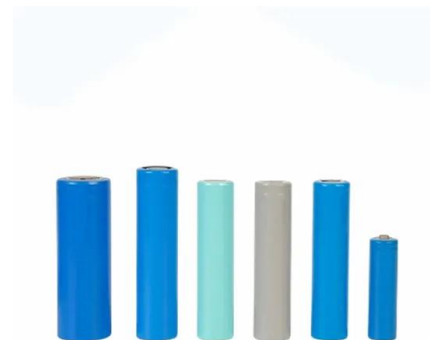
