Buying a solar energy system makes you eligible for the Solar Investment Tax Credit, or ITC.

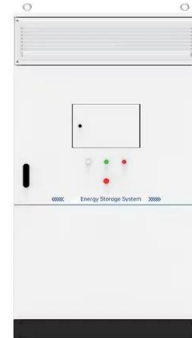
