

# Government subsidy for collapsible solar panel container in Sweden





### **Overview**

Will Sweden reduce the subsidy for solar?

The Swedish government is considering reducing the subsidy for solar installations and removing the income tax reduction for households and businesses that micro-produce renewable electricity. Svensk Solenergi, Sweden's leading solar association, has criticized the proposals.

Are solar panels tax deductible in Sweden?

For homeowners in Sweden considering installing solar panels, you can benefit from tax reductions for the cost of both labor and materials - the green deduction (grön teknik) and the ROT deduction. This article outlines the size of these deductions, their conditions, and which is best to use when installing solar panels.

Will Sweden reduce tax breaks for green energy projects?

In a move that has sparked significant debate, the Swedish government has put forward a proposal aimed at reducing tax breaks for green energy projects. The goal?

To generate an estimated 8.5 billion kronor (approximately \$773 million), which will be funneled into funding tax cuts, particularly benefiting middle-income earners.

What subsidies are available for solar roof installations?

There are two main subsidies, the Green Deduction (grön teknik) and ROT. Generally, one can avail of either the grön teknik or the ROT deduction, but not both. In the case of solar roof installations, it's possible to utilize both the ROT and grön teknik.

Will the government stop subsidized solar cells?

It also plans to scrap the tax reduction for the micro-production of renewable



electricity. The ministry said in a statement on the government's website that installations have increased sharply, which is why there is no longer a need to subsidize solar cells.

Will solar cell support be replaced by tax reduction for green technology?

In 2021, solar cell support will be replaced by the Tax Reduction for green technology. The solar cell support gave the right to a percentage compensation of the total system cost, which meant that the magnitude of the various costs for a solar cell installation on a villa did not play a role in the level of support.
