What subsidies are available for solar panels in Castile & Leon?

Subsidies for the installation of solar panels in Castile and Leon can be up to 40% of the total cost of the installation. ICIO tax rebates: up to 95%. There will be subsidy discounts in municipalities with less than 5,000 inhabitants and SMEs.

How long does it take to get a subsidy for solar panels?

In the case of acceptance, you have a maximum period of 18 months to grant the subsidy for the installation of solar panels for self-consumption. The grants are awarded by simple concurrence, which means that the applications are attended in order of presentation until the funds are exhausted.

How much does a PV system cost?

Subsidies vary depending on the power output: up to €2,000/kWp for PV installations without storage and up to €3,500/kWp with storage (storage can be storage tanks, heat exchangers, expansion vessels, pipes, valves and connections, circulation pumps, insulation).

How much is a next generation electricity subsidy?

The government also offers Next Generation funds originating from the European Union. For installations of less than 10 kWp, the most common for homes, the amount can reach up to €600 per kWp. If you add a battery, you get a subsidy of €490 per kWh. Income Tax Deduction (IRPF).


