On 22 October 2024, the Government of Vietnam issued Decree No. 135/2024/ND-CP stipulating policies encouraging development of self-produced and self-consumed rooftop solar power ("Decree 135"), which would immediately take effect from the date of issuance. Decree 135 ends nearly four years of.




