

In 2021, solar cell support will be replaced by the Tax Reduction for green technology. The solar cell support gave the right to a percentage compensation of the total system cost, which meant that the magnitude of the

When will solar subsidy come into force?

If agreed upon, the reduced subsidy for solar cells would come into force on July 1, 2025, while the removal of the micro-production tax reduction would occur at the start of 2026. The ministry said the policy changes will help to increase tax revenue by up to SEK 880 million (\$86.7 million) in 2026.


