# **Government subsidy for containerized microgrid in Netherlands**





## Overview

---

The Dutch government has earmarked €100 million (\$106.7 million) of subsidies for the deployment of battery storage alongside PV projects. The funds are part of a €416 million subsidy program announced last year to alleviate grid congestion. How can I apply for a subsidy scheme for large scale hydrogen production?


