There are still three important things to know: You might be disappointed to read that solar panel grants in Spain (sometimes amounting to over €3,000 for regular-sized solar panel installations) are not set in stone in 2024.

What subsidies are available for solar panels in Castile & Leon?

Subsidies for the installation of solar panels in Castile and Leon can be up to 40% of the total cost of the installation. ICIO tax rebates: up to 95%. There will be subsidy discounts in municipalities with less than 5,000 inhabitants and SMEs.

What financing options are available for solar projects in Spain?

Power Purchase Agreements (PPA's) and Crowdfunding are two exciting forms of funding that have entered the solar sector here in Spain. These methods of financing are particularly interesting to businesses and communities. Finance is also available to residents of Spain who have a regular payment into a Spanish bank account.

When will solar panels be approved in Spain?

But this funding ended on December 31st 2023. The Spanish government has requested for funding to continue until 2026. However, at the time of writing this there is no confirmation of further solar panel subsidies in Spain. They may be approved in the coming months.



How much do solar panels cost in Galicia?

Subsidies for the installation of solar panels in Galicia are 50% of the total budget, with a maximum amount of €60,000. Grants: the IBI deduction for the installation of photovoltaic panels is 50% for 3 years (depending on the regulation of each province).
