


Government subsidy for mobile foldable pv system in Portugal





Overview

Are there subsidies to rooftop PV solar?

There is in place a governmental fund (Environmental Fund) which includes subsidies to rooftop PV solar in the context of the Recovery and Resilience Program, with separate calls for individual units on one hand and CSC (collective self-consumption) and energy communities on the other.

How much subsidy does a photovoltaic project receive?

The amount of subsidy for the installation of photovoltaic panels and other equipment towards energy production from renewables, for self-consumption, is of 70% of the cost of the project, up to a limit of EUR 2,500 (art. 6.3 Order 8745/2020).

How much does Portugal pay for solar panels?
