

Italy has set aside 5.7 billion euros for Renewable Energy Communities (RECs) 1. This shows its strong support for renewable energy. The goal is to make 40% of energy come from renewables by 2030 2. The European Commission has given the green light for 4,590 MW of new renewable energy capacity 3.

The European Commission has approved, under EU State aid rules, a €5.7 billion Italian scheme made available in part through the Recovery and Resilience Facility ('RRF') to support the production and self-consumption of renewable electricity. The scheme contributes to the EU's strategic objectives.
