# **Government subsidy for mobile solar container in Malaysia**





## Overview

On 27 March 2024, the Ministry of Energy Transition and Water Transformation announced a special incentive known as the Solar for Rakyat Incentive Scheme ("SolarIS"). The SolarIS aims to encourage the installation of solar photovoltaic systems by domestic consumers. Should you switch to solar power in Malaysia?

1. Broader Options for Solar PV system Installations Previously, the SelCo programme restricted solar photovoltaic (PV) installations to rooftops with a capacity cap of 85% of a building's maximum electricity demand. The new guidelines remove these limitations, allowing:.

Can a business claim a 100% capital allowance for a solar project?

GITA allows businesses to claim a 100% capital allowance, which can offset up to 70% of statutory income over 5 years. This applies whether you're using the solar system internally or for green projects. GITE offers up to 70% income tax exemption for solar leasing projects (between 3-30 MW), with durations of 5-10 years depending on project size.
