The Ministry of Finance on March 18, 2025, published a proposal (Swedish) that would reduce tax subsidies for installing solar cells. Sweden has surpassed its solar energy target of 2.2 GW and is now aiming for 6.6 GW in the revised NECP draft, though overall renewable energy contributions are pending as the Renewable Energy Directive revision process comes to an end. What subsidies are available for solar roof installations?

There are two main subsidies, the Green Deduction (grön teknik) and ROT. Generally, one can avail of either the grön teknik or the ROT deduction, but not both. In the case of solar roof installations, it's possible to utilize both the ROT and grön teknik.

Will the government stop subsidized solar cells?

It also plans to scrap the tax reduction for the micro-production of renewable electricity. The ministry said in a statement on the government's website that installations have increased sharply, which is why there is no longer a need to subsidize solar cells.

Should energy communities be regulated in Sweden?

The Swedish regulator recommends that energy communities adopt the legal form of economic associations (the Swedish version of cooperatives) and adopt an overarching concept with two operative definitions: citizen energy communities and renewable energy communities. This should contribute to promoting a coherent approach.

When will solar subsidy come into force?

If agreed upon, the reduced subsidy for solar cells would come into force on July 1, 2025, while the removal of the micro-production tax reduction would occur at the start of 2026. The ministry said the policy changes will help to increase tax revenue by up to SEK 880 million (\$86.7 million) in 2026.

Can I get a tax refund on a solar panel installation?

After that, the company asks for a refund from the tax authorities. So, you



don't have to handle the deduction yourself. To be eligible for the ROT deduction on a solar panel installation, the installation must be carried out by a company that is registered for F-tax (a Swedish corporate tax).
