The National Assembly of Panama adopted Law 417, published on 27 December 2023, which revises Law 37 of 2013 and broadens the incentive framework for the solar power sector. New incentives include tax exemptions and import duty reliefs for all individuals and entities involved in the solar.

Panama eliminates the selective consumption tax of the import tax and other levies on equipment for the construction, operation and maintenance of power plants and/or solar installations with Law 417 of December 27, 2023. This was legalized and in force in the Official Gazette number No. 29938-A of.

Among the Central American states, Panama has become very attractive to investors, not only because it boasts a stable government and uses the US dollar as its currency, but also due to the government now deploying a range of fiscal incentives to support PV, including an exemption on import taxes.



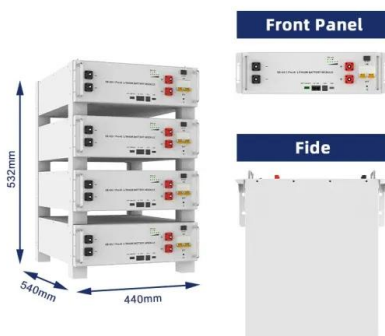


