Subsidies for the installation of solar panels in Castile and Leon can be up to 40% of the total cost of the installation. ICIO tax rebates: up to 95%. There will be subsidy discounts in municipalities with less than 5,000 inhabitants and SMEs.

Are EU-funded solar grants still being paid out in 2024?

The EU-funded solar grants are still being paid out in 2024 even though the deadline to apply for them was 31st December 2023. As we said above, people have actually received this subsidy already. But in case you want to see how it worked let's take the example of a 5 kW system.

How much is a next generation electricity subsidy?

The government also offers Next Generation funds originating from the European Union. For installations of less than 10 kWp, the most common for homes, the amount can reach up to €600 per kWp. If you add a battery, you get a subsidy of €490 per kWh. Income Tax Deduction (IRPF).

How much does a PV system cost?

Subsidies vary depending on the power output: up to €2,000/kWp for PV installations without storage and up to €3,500/kWp with storage (storage can be storage tanks, heats exchangers, expansion vessels, pipes, valves and connections, circulation pumps, insulation).
