The government will offer tax breaks for homes, businesses, and farms that install panels and connect to the grid under the new program. Homeowners will now have access to a tax credit of up to NIS 30,000 (\$8,000) for installing panels, while businesses and farms can get up to NIS 100,000.

The incentive scheme awards a 23-year, \$0.12/ kWh feed-in tariff to roof arrays with a generation ability of approximately 200 kW. Currently, 141 municipalities have actually applied to set up 116 MW of roof solar ability and also the federal government has actually raised the program's spending.
