

Government subsidy for portable solar power box in France





Overview

Does France offer subsidies for solar panels?

Many regions in France offer additional subsidies for solar panel installations. These initiatives can significantly lower initial costs. To qualify for government subsidies, it is recommended to hire certified professionals with the RGE (Reconnu Garant de l'Environnement) license.

What is a solar subsidy?

It is a one-off subsidy paid for by energy suppliers to help cover some of the costs of panel installation and is aimed at solar thermal panels, whether just to heat hot water or also for the central heating system. Photovoltaic panels are not eligible.

Who financed the installation of photovoltaic panels in Bourg-en-Bresse?

It is financed by the CA3B (Communauté d'Agglomération du Bassin de Bourg-en-Bresse) Renewable Energy Fund. For the installation of photovoltaic panels, assistance can reach a minimum of 10% of the cost of eligible work, up to a maximum of €15,000, and up to 25% depending on the applicant's situation.

Does EDF buy back surplus solar energy?

National energy companies such as EDF has an obligation to buy back surplus energy produced by solar panels. This bonus is only for the installation of photovoltaic panels.

How much does a ground-mounted solar project cost in France?

Broadly speaking, for ground-mounted solar projects located in mainland France, the FIT will be reduced from EUR 570 per MWh to EUR 30 per MWh. The minimum FIT will be in the range of EUR 18 to EUR 50 per MWh, and the average FIT will be around EUR 30 per MWh.

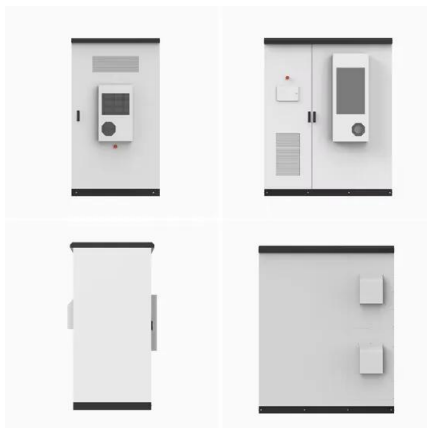

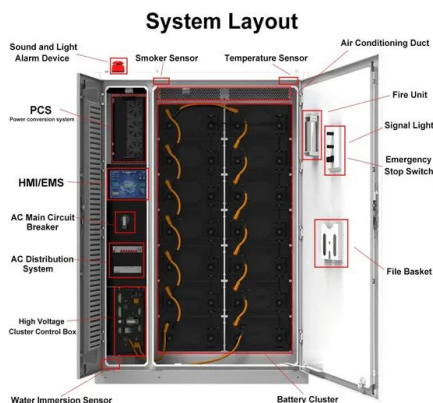
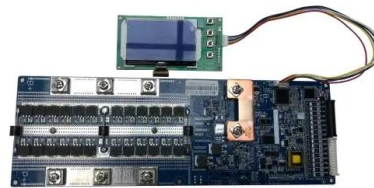
