

Government subsidy for portable solar power box in Turkey

With Decree n. 7189, published this week in the official gazette, the Turkish authorities have set a 10-year FIT of TRY 1.06/kWh for PV systems that installed between July 1, 2021, and Dec. 31, 2030. What incentives are available for solar panels in Turkey?
