Article 85 of the Climate and Resilience Act dated 22 August 2021 created Article L. 352-1-1 of the French Energy Code, which provides for the use of calls for tenders to develop electricity storage capacities. Enedis manages most of the electricity distribution activities in France. It operates a network of 1.4 million km and distributes 95% of the volume of electricity distributed in France. Energy production sites with a capacity of less than 12 MW are directly connected to the grid through the entities distributing power to end-users.


