How did Zar's energy subsidies change in FY 2017/18?

Electricity subsidies increased by 8% to ZAR 16 billion (USD 960 million) and oil and gas subsidies by 18% to ZAR 35 billion (USD 2.1 billion). Support for nuclear energy increased from ZAR 590 million in FY 2017/18 to ZAR 920 million in FY 2020/21 (USD 60 million).

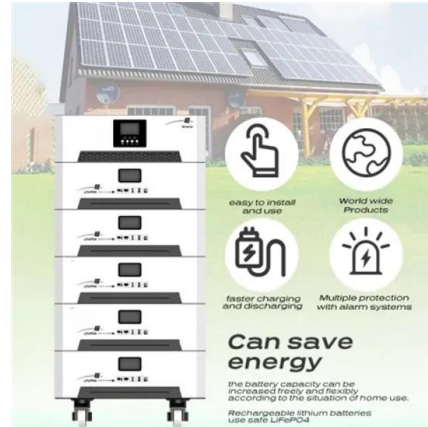

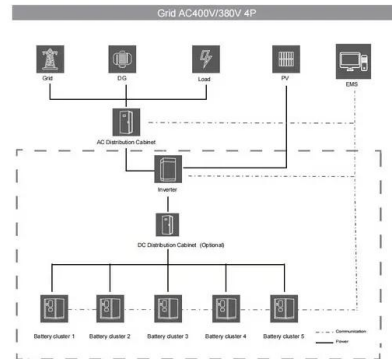
