The Tunisian authorities have provided \$121 million for solar thermal and PV systems. The subsidies can cover up to 30% of initial investments in residential PV installations. The Tunisian government said that it has renewed the financing mechanism for its two national residential solar programs.

Major investments in solar power could be coming to Tunisia after the local government granted building licenses to multiple international solar companies. The North African country awarded more than \$386 million worth of licenses to solar firms from France, Norway, and Japan. The projects will be.

In 2010, Tunisia launched the Prosol Elec program to promote the installation of solar panels on roofs connected to the low-voltage grid through subsidies and loans. MW of solar panels by December 2024. 1,200 and 1,800 kWh/ year. 66,000 households are scheduled to take part in this initiative.A.




