Poland's Ministry of Climate and Environment has announced the launch of the sixth edition of the "My Electricity" (Mój Prąd) program. This initiative, set to begin on September 2, 2024, and run until December 20, 2024, or until funds are depleted, aims to further support the adoption of renewable.

The sixth edition of the Polish government's residential solar and storage rebate scheme is now open, with a total budget of PLN 400 million (\$103.2 million). Applications will be accepted until Dec. 20, or until funds are exhausted. Poland's National Fund for Environmental Protection and Water.

The Polish government has unveiled details of the subsidies available under the "My Electricity 6.0" program, aimed at boosting solar energy adoption. The initiative, announced by the Ministry of Climate and Environment, offers financial support to households and small businesses investing in.


