Overview

Why are solar panels exempt from import taxes in Brazil?

In recent years, solar panels have been exempted from import taxes in Brazil – a subsidy that was revoked this year, as a 10.8% tax was introduced. The exemption had helped to make solar equipment cheaper to source from China than domestically, and contributed to Brazil emerging as the second-largest importer of Chinese solar panels.

Is solar a viable source of electricity in Brazil?

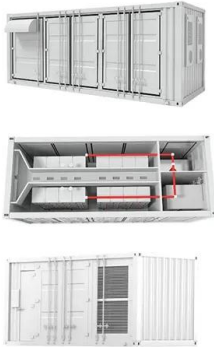

Is Brazil a good producer of solar energy?

Just three years ago, Brazil did not feature among the world's top producers of solar energy, but by 2023 it had risen to sixth place in the rankings. The pace of growth has been notable: since 2022, the country has added, on average, roughly one gigawatt of solar capacity every month.

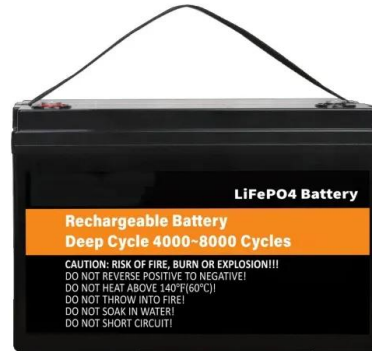
