The state government offers subsidies up to 40% for solar rooftop systems, depending on system capacity. Additionally, Punjab promotes solar-powered irrigation systems for farmers. Rajasthan, known for its vast solar potential, has a well-established Rajasthan solar subsidy scheme.

Will government give subsidies for rooftop solar panels in 2024-25?

The Budget 2024-25 emphasised this yojana and provided that the government will give subsidies for the installment of solar panels to 1 crore households. Under this scheme, subsidies are provided for installing rooftop solar panels for residential houses to supply power to households.

Which solar systems are eligible for subsidy in India?

The solar systems applicable for subsidy are the on-grid solar systems, hybrid solar systems, and solar water pumps. The subsidy percentage varies from state to state and the majority of states provide nearly 30% to 90% subsidy in India.
