

Currently, there is no specific GST exemption for solar power projects. All solar power-based devices and systems are taxed at a 12% rate under the GST regime. 4.

Are solar panels taxed under GST?

These systems are generally taxed at 12% under the GST regime. This rate applies to all equipment and components used in generating solar power, ensuring consistency in taxation across the sector. Solar inverters, which convert the DC electricity generated by solar panels into AC electricity used by most appliances, are taxed at a GST rate of 12%.
