

# **Gst rate on solar panel**

For commercial solar projects or EPC (Engineering, Procurement, and Construction) contracts, the gst for solar power plant is also 5%, provided it is a composite supply. This means the entire system — panels, inverters, cabling, structure, and installation — is billed together under one contract. What Is the Solar System GST Rate?

Does GST apply to solar panels?

As per the GST regulations: 18% GST applies to solar panel devices. Installation services bundled with solar panels may attract GST rates as low as 5%, depending on the specific contract. The GST rate for solar power-based devices is 18%, as outlined by the government.

What is the GST rate for solar power generating system (composite supply)?

The applicable GST rate for supply of equipment for a solar power generating system (composite supply) will be 12% (the value can be equivalent to 70% of the plant cost).

How much GST does a solar project cost?

All renewable energy devices are taxed at 12% GST. But, if the project includes erection, procurement, and commissioning of a solar generating system, it will fall under 'Works Contract Services'. In this case, 12% GST will be applicable on 70% of the total contract value and 18% on the remaining 30% value.

How much GST does a solar inverter cost?



This includes panels sold directly or as part of a larger system. The gst on solar inverter is 5% only if it is sold as part of a solar system. If purchased separately (not with solar panels), the GST rate is 18%. So, to get the benefit of a lower rate, it's recommended to buy the complete solar system from a single supplier.
