SEATTLE (April 23, 2024) - Today, the U.S. Environmental Protection Agency announced Oregon Department of Energy has been selected to receive \$86,600,000 through the Solar for All grant competition to develop long-lasting solar programs that enable low-income and disadvantaged communities to deploy.

On April 22, the U.S. Environmental Protection Agency (EPA) announced that the Oregon Solar for All Coalition (OSFAC), consisting of Oregon Department of Energy, Energy Trust of Oregon and Bonneville Environmental Foundation, would be awarded \$86.6 million dollars through its Solar For All.

The U.S. Environmental Protection Agency awarded Oregon a \$86.6 million Solar for All grant to support renewable energy adoption for low-income Oregonians. The grant is one of the largest ever investments to connect more people with solar energy and is part of a \$7 billion Solar for All program.

The Oregon Department of Energy, together with our partners Energy Trust of Oregon and Bonneville Environmental Foundation, have been awarded an \$86.6 Million Solar for All Grant from the U.S. Environmental Protection Agency. The award was announced on April 22, 2024. Oregon's program will aim to serve over 8,000 households with low incomes.

What is the Solar for all grant program?

The U.S. EPA's Solar for All competitive grant program, made available under the Greenhouse Gas Reduction Fund is focused on providing benefits from solar energy to low-income households and disadvantaged communities.

What grants are available for solar panels?

The Pennsylvania High Performance Building Incentives Program offers grants of up to 10 percent of the cost of building a "green" home, including solar panels. The ClimateSmart Solar Grant Program in Boulder, Colorado, has energy grants for low-income housing that provide up to 50 percent of the funding for solar panels.

How will EPA funds bolster solar in Oregon?

The funds will bolster solar in Oregon in several ways, including through: Funded by the EPA, Solar for All aims to save low- and moderate-income households around \$350 million annually on energy costs, while also significantly reducing emissions.

How do I get solar incentives in Oregon?

You must be an Oregon customer of Portland General Electric or Pacific Power and working with an approved Energy Trust solar trade ally contractor to be eligible for incentives. Get proposals from Energy Trust solar trade ally contractors. Systems must be installed by an approved Energy Trust solar trade ally contractor.

Which electric utilities offer solar incentives in Oregon?

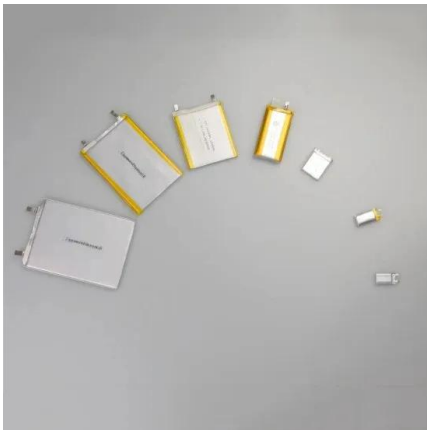
