Can a business get a grant for solar panels?

Currently, there are no direct grants for businesses specifically for solar panel installation. However, businesses that invest in solar panels could benefit from the Smart Export Guarantee (SEG), which enables small low-carbon electricity generators to receive payments for the surplus energy they export back to the grid.

What are solar energy grants?

Solar Energy grants provide competitive funding to install solar at public buildings and facilities, such as schools, hospitals, civic buildings and wastewater treatment plants. These grants cut energy costs, reduce pollution and showcase solar projects in communities across the state.

What are small scale solar grants?

Commerce RI's Small Scale Solar Grants program is designed to encourage adoption of photovoltaic solar and solar hot water technology among Rhode Island homeowners. This is one of the few grants for small scale solar installations in the country that most local homeowners are eligible for.

Are there grants for residential solar?

Grants for residential solar installations are extremely scarce. However, tax credits, utility rebates, and performance incentives are more common for residential solar (more on these in the last section).
