Roughly \$7 billion for building solar renewable energy projects has been released from a federal funding freeze first issued in January, including more than \$500 million earmarked for tribal communities. The Solar for All (SFA) Program is part of the \$27 billion Greenhouse Gas Reduction Fund.

The Environmental Protection Agency abruptly announced the cancellation of all \$7 billion in Solar for All grants, was a national setback for clean energy access. For groups like GRID Alternatives, the country's largest nonprofit solar installer, the impact is measured in very specific losses: tens.
