The Solar For All grant is available to states, territories, municipalities and eligible nonprofits through the Inflation Reduction Act 's Greenhouse Gas Reduction Fund, which seeks to provide low-income and disadvantaged households access to affordable solar energy. Will EPA grants go to residential solar projects?

The EPA grants will go toward residential solar projects. The Environmental Protection Agency has announced the selection of 60 recipients of \$7 billion in grant awards through the Solar for All grant competition, the agency said Monday.

What is a solar grant?

The grant awardees have been selected to deliver residential solar projects to more than 900,000 households with the goal of developing long-lasting solar programs that benefit low-income and disadvantaged communities, according to the EPA.

What is a solar for all award?

One hundred percent of the Solar for All awards are meant to benefit communities defined by EPA as low-income and disadvantaged (LIDAC).

What is the \$7 billion solar for all program?

Under the \$7 billion Solar for All program, the 60 grant recipients will create new or expand existing low-income solar programs, which will enable over 900,000 households in low-income and disadvantaged communities to benefit from distributed solar energy.

How many solar for all awards are there?

The 60 Solar for All awards include 49 state-level awards, 6 awards serving Tribes, and 5 multi-state awards, all of which will either expand existing low-income solar programs, or create new solar programs that benefit LIDAC.


