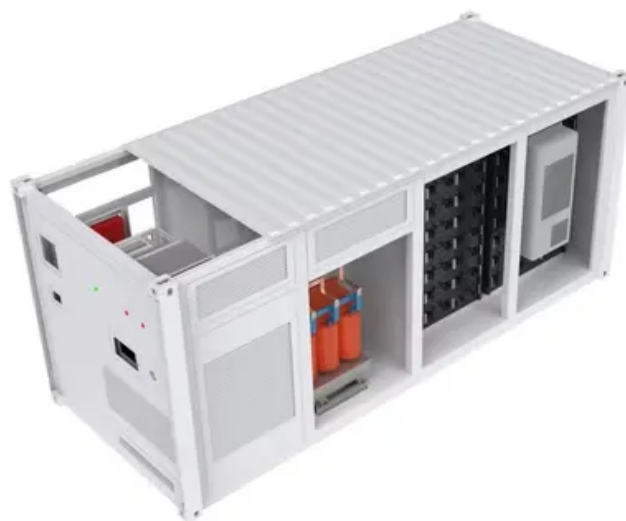

"Solar for All is an investment in energy infrastructure that's going to serve that residential customer that's going to keep energy rates in America more affordable and more fair," she said. Solar for All awarded grants in August 2024 to 49 state-level agencies, six tribes and five multi-state award recipients, according to the EPA.

What does Nofo stand for?

(NOFO) is for the \$7 billion Solar for All competition. This competition will award up to 60 grants to states, territories, Tribal governments, municipalities, and eligible nonprofit recipients to expand the number of low-income and disadvantaged communities primed for distributed solar investment—enabling millions of low-income households.
