

SEATTLE - Today, the U.S. Environmental Protection Agency (EPA) announced that the Washington State Department of Commerce was awarded \$156,120,000 in funding through the Greenhouse Gas Reduction Fund's Solar for All program. The competition, created by President Biden's landmark Inflation.

Washington has regained access to more than \$150 million in previously frozen federal funds for solar energy projects, state officials said. For at least a



week, the state Department of Commerce was locked out of its Solar for All grant money expected to help thousands of residents in low-income.

In a significant development for Washington State, access to over \$156 million in previously frozen federal funding for solar energy projects has been restored. This funding is crucial for the state's Solar for All initiative, which aims to enable low-income communities to harness solar power. Does solar work in Washington?

Solar for All will advance equity and environmental justice through new and expanded solar programs for income-qualified households, disadvantaged communities and tribes. The program is funded by the Environmental Protection Agency's Greenhouse Gas Reduction Fund created by the federal Inflation Reduction Act.


