

# Solar for low income program







#### **Overview**

What is a low-income solar program?

A low-income solar program is designed to serve families at or below 80% of the area's median income (AMI), as defined by the U.S. Department of Health and Human Services. Most of these programs in the U.S. aim to make solar energy more accessible to low-income households.

What kind of incentives do low-income solar programs offer?

Low-income solar programs may provide assistance with upfront costs through rebates, grants, or discounts. Others provide performance-based incentives to earn higher electricity bill savings each month. Some low-income assistance programs to reduce or eliminate solar financing costs are also available.

Do low-income solar programs offer free solar panels?

Low-income solar programs don't typically provide completely free solar panels. However, they can greatly reduce installation costs by offering rebates or grants to cover the majority of rooftop solar installation costs for qualified applicants. There may still be some costs or payments required.

What are low-income solar incentives for single-family homes?
