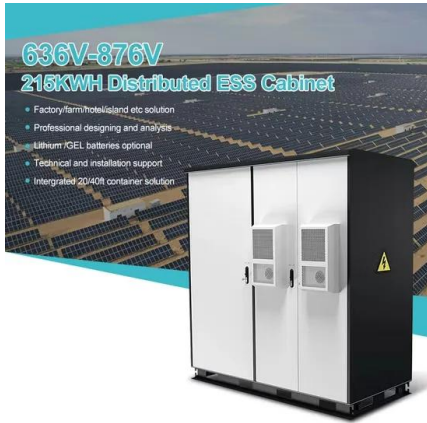
How much does a solar loan cost in NSW?



The NSW government also created a scheme to provide interest-free loans for new solar batteries and new panel and battery systems. The loans ranged between \$9,000 - \$14,000 to households that met the eligibility criteria. The interest-free loan program with NSW government has now closed.

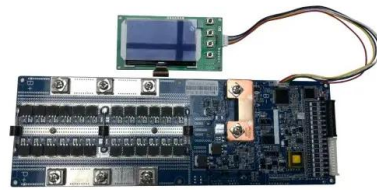
