Can a building contractor install solar panels?

While solar contracts will differ by provider and project, most of them contain a certain amount of shared verbiage and content.

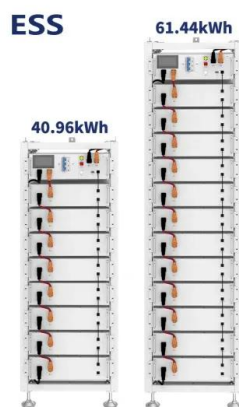
