Why did solar companies go out of business?

Because solar was more expensive in the 2010s, many entered into leases with solar companies to defray upfront costs, and many were left in the lurch when those companies went out of business.

How did rooftop solar grow in the 2010s?

The leasing model helped rooftop solar flourish in the 2010s, eliminating at least one barrier to adoption: high upfront costs for homeowners. Companies got the money to finance these costly installations from packaging and selling tens of thousands of solar leases to private equity and institutional investors.



Are radiant solar panels 'not working' in New York?

According to the state and city divisions of consumer protection, more than two dozen New Yorkers have filed a complaint against Radiant Solar. Customers claim the panels are "not working," "inspections failed," or the company has been "unresponsive." The city says they can't comment in detail, but they've launched an investigation.


