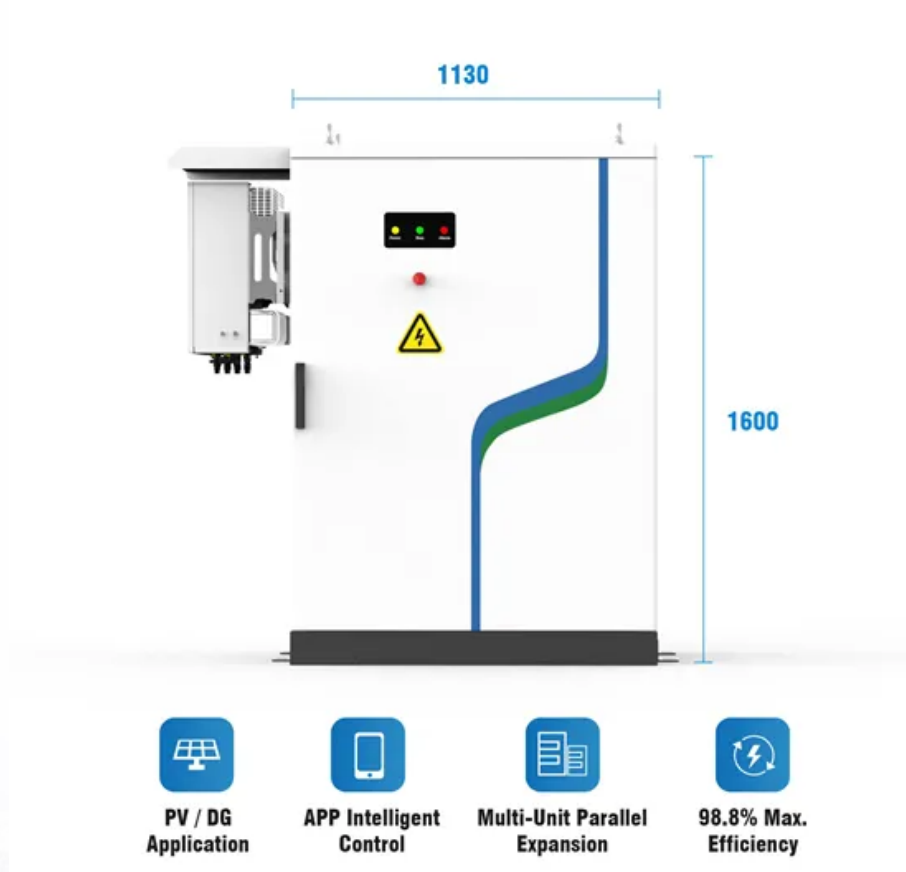

Launched by Prime Minister Shri Narendra Modi on 13th February 2024, this transformative scheme is rapidly.

The Government of India has approved the PM Surya Ghar: Muft Bijli Yojana on 29th February, 2024 to increase the share of solar rooftop capacity and empower residential households to generate their own electricity. The scheme has an outlay of Rs 75,021 crore and is to be implemented till FY.

The PM Surya Ghar Muft Bijli Yojana is a central government scheme launched on 15 February 2024. It provides up to 300 units of free electricity per month to eligible households through rooftop solar panel installations. The scheme offers subsidies up to Rs. 78,000 to poor and middle-income.

Will government give subsidies for rooftop solar panels in 2024-25?

The Budget 2024-25 emphasised this yojana and provided that the government will give subsidies for the installment of solar panels to 1 crore households. Under this scheme, subsidies are provided for installing rooftop solar panels for residential houses to supply power to households.

How do households apply for solar subsidy?

The households will apply for subsidy through the National Portal and will be able to select a suitable vendor for installing rooftop solar. The National Portal will assist the households in their decision-making process by providing relevant information such as appropriate system sizes, benefits calculator, vendor rating etc.

How much solar capacity will India's Solar System add?

Expansion of Solar Capacity: The scheme is projected to add 30 GW of solar capacity through rooftop installations in the residential sector, significantly contributing to India's renewable energy goals.

How much is CFA for solar panels in India?



The CFA will be capped at 3 kW. At current benchmark prices, this will mean Rs 30,000 subsidy for 1 kW system, Rs 60,000 for 2 kW systems and Rs 78,000 for 3 kW systems or higher. The households will apply for subsidy through the National Portal and will be able to select a suitable vendor for installing rooftop solar.
