Do solar panels qualify for a federal tax credit?

The IRS states in Questions 25 and 26 in its Q&A on Tax Credits18 that off-site solar panels or solar panels that are not directly on the taxpayer's home could still qualify for the residential federal solar tax credit under some circumstances.
