How do solar rebates work?

Unlike tax credits, rebates are typically received as a direct payment or a discount on the purchase price. For example, if there is a \$1,000 rebate on a \$10,000 solar panel system, you pay \$9,000, or if you pay the full amount upfront, you might receive \$1,000 back after the purchase. ## Is a solar rebate a tax refund?
