Can a business get a grant for solar panels?

Currently, there are no direct grants for businesses specifically for solar panel installation. However, businesses that invest in solar panels could benefit from the Smart Export Guarantee (SEG), which enables small low-carbon electricity generators to receive payments for the surplus energy they export back to the grid.

What are solar energy grants?

Solar Energy grants provide competitive funding to install solar at public



buildings and facilities, such as schools, hospitals, civic buildings and wastewater treatment plants. These grants cut energy costs, reduce pollution and showcase solar projects in communities across the state.

Are there grants for residential solar?

Grants for residential solar installations are extremely scarce. However, tax credits, utility rebates, and performance incentives are more common for residential solar (more on these in the last section).

How do solar grants work?

For homeowner-owned solar installations, the grant system offers a \$1.05 per watt incentive, with a cap of \$10,000. Homeowners receive these grants based on the size of their installation. If the homeowner owns the solar installation (instead of leasing or through a Power Purchase Agreement, or PPA), they receive a higher incentive.

What solar panel grants are available in 2022?

The main solar panel grant available in the UK in 2022 is ECO4 funding. This grant covers up to 70% of the cost of solar PV systems for domestic properties. Other grants are available for commercial properties, community energy projects, and solar farms. For more information, visit the government website.
