Here's is how this law impacts residential solar: The 30% solar tax credit claimed by homeowners (25D) would be terminated at midnight on December 31, 2025. Homeowners who have their systems installed before the end of the year can still claim this credit against their federal tax liability.

Do solar panels qualify for a tax break?

Whether you're looking to install solar panels, invest in a solar plus storage system or add a battery to an existing system, you may qualify for a tax break from the government. The residential clean energy credit is one of the best incentives available to taxpayers who own their solar panels or other clean energy equipment.

Does the US have a solar tax credit?

In an effort to encourage Americans to use solar power, the US government offers tax credits for solar systems. The Inflation Reduction Act renamed and extended the existing solar tax credit through 2034 for solar system installations on residential property. It also increased the credit's value.

How do solar tax credits work?

Typically, you can reduce your tax bill by the exact value of the tax credit. For example, if you claim a \$1,000 federal tax credit, you will pay \$1,000 less in taxes. The federal solar tax credit, which is often referred to as the investment tax credit or ITC, works exactly the same way.

Do state rebates affect solar tax credits?

In general, rebates from state governments will not affect your federal solar tax credit because they don't often lower the overall cost of the system. State tax credits don't usually have an impact on federal credits, and federal credits don't usually affect state credits.

Can a third-party-owned solar system claim tax credits?

These third-party-owned systems can still claim tax credits for systems that



begin construction before July 2026 or are placed in service before 2028, but those tax credits will be available for the company that owns the system, not to the homeowner leasing the panels.


