Solar incentives come in one of three major types: Tax breaks - Income tax credits are the most popular kinds of tax breaks, but state and local governments also commonly offer sales and property tax exemptions.

Which states offer solar incentives?

Depending on where you live, you may be eligible for additional solar incentives, such as tax breaks and rebates. Overall, New York and Oregon



have the most state-funded solar incentive programs. In some states, recent changes to net metering policies mean that people with solar panels earn less when they sell electricity to their local power grid.

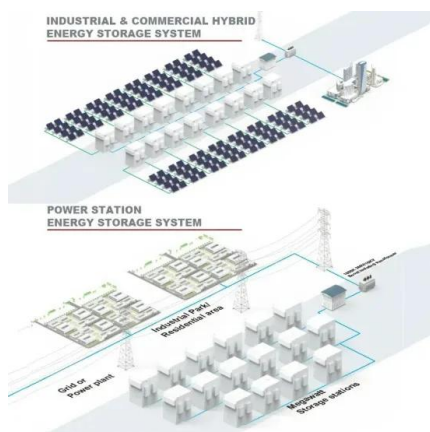
