If you made improvements to more than one home, list the complete address of the home with the greatest total cost in the section above line 1. Then, attach a statement listing the additional addresses to Form 5695. Enter the amounts you paid for qualified solar electric property. See Qualified solar electric property costs, earlier.

How do I calculate my solar installation tax credit?

Go to Part I, Line 1 – enter your total qualified solar installation costs. Complete the calculations on Lines 6a through 13 to determine your 30% credit. Transfer the final credit amount to Form 1040, Schedule 3, Line 5. For Example, if your total solar installation cost is \$25,000, your 2025 tax credit is \$7,500.

What is a solar investment tax credit?

The Residential Clean Energy Credit (also known as the solar investment tax credit or ITC) is a tax credit for homeowners who invest in solar and/or battery storage. Thanks to the Inflation Reduction Act, the 30% credit is available for homeowners that install solar from 2022 to 2032.

When can I claim a solar system tax credit?



The credit can be claimed for the tax year when the solar system was placed in service. If your project isn't finished (e.g., waiting on final inspection or utility hookup) until January, then it's "placed in service" in that year, not the previous one. So install timelines matter for which year's return to claim the credit.


