earlier, an EPC Contract is one of a suite of agreements necessary to develop a solar project.

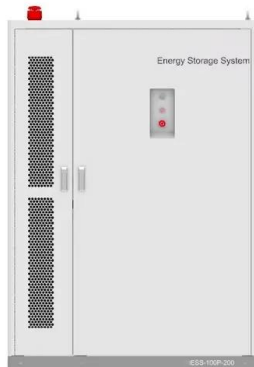
What is a bankable EPC contract?
