

Vat on installation of solar panels

To claim 0% VAT on solar panels and relevant equipment, they must be: installed on residential properties or buildings that are used for charitable purposes. new and not second-hand. fitted by a MCS-registered installer. bought and installed with the same provider or a 20% VAT charge could be.

Reduced rate VAT on solar panels. Reduced to zero in 2023 for residential systems up to 30 kW. Effective from 1 January 2024 until the end of 2025 for systems up to 35 kW. Standard rate is 21%. For homes less than 10 years old; usual rate is 21%.

panel installations in January 2024. According to the latest data from Microgeneration Certification Scheme (MCS), over 1.4 million solar panel systems have been installed across the UK, up from 1.2 million in 2022.

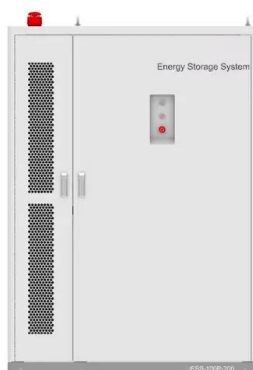
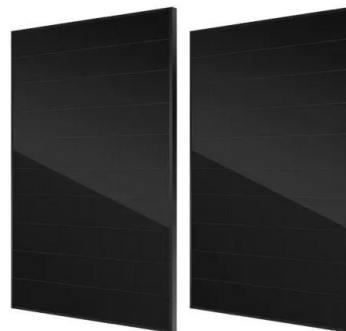
